1. Yard waste, yard trash and clean wood are being collected for further processing.
2. Windrows should be turned periodically and monitored for hot spots.

Concrete Stockpile/Crushing Area

3. Concrete continues to be collected in the stockpile area.
4. The crushing of concrete was ongoing at the time of this inspection.
5. Efforts to reduce the concrete stockpile are ongoing.

6. The compost from the compost demonstration was windrowed in the designated area for curing.
