ADDITIONAL COMMENTS

1. The facility was permitted as a Construction and Demolition waste treatment and processing site.
2. The facility began operations on June 13, 2005.
3. Due to economic considerations, the facility discontinued accepting C&D waste for processing and began operating as a recycling facility in 2007.
4. Previous discussions with the facility have been conducted concerning the possibility of re-applying for a permit in the future. Permit renewal requests were submitted to the Solid Waste Section for the expired permit, the last submittal being July 2008.
5. As per discussions with Mr. Triolo at the site on December 4, 2014, the facility has no plans to accept C&D waste in the future. No Solid Waste Permit should be required for the facility.
6. The facility accepts only clean metal, e-waste, selected plastics, cardboard, and selected paper for sorting and processing.
7. All storage areas, stockpiles, and processing areas from the previous C&D processing operations have been removed from the site, as noted in previous visits.
8. The operations at the facility require no permits from the Solid Waste Section and recommend inactivating the site listed as 4121-TP, Salvage America, Inc.
