The item(s) listed above were observed by Section staff and require action on behalf of the facility in order to come into or maintain compliance with the Statutes, Rules, and/or other regulatory requirements applicable to this facility. Be advised that pursuant to N.C.G.S. 130A-22, an administrative penalty of up to \$15,000 per day may be assessed for each violation of the Solid Waste Laws, Regulations, Conditions of a Permit, or Order under Article 9 of Chapter 130A of the N.C. General Statutes. Further, the facility and/or all responsible parties may also be subject to enforcement actions including penalties, injunction from operation of a solid waste management facility or a solid waste collection service and any such further relief as may be necessary to achieve compliance with the North Carolina Solid Waste Management Act and Rules.

**ADDITIONAL COMMENTS:**

1. During this inspection I met with Ronnie Locke, Enfield Planning and Zoning and Lamar Caudle, Interim Enfield Public Works Director. Greg Griffin, who was the town's Public Works Director, became the county public works director. A replacement has not been hired. Mr. Locke's e mail can be used as Mr. Caudle does not have an e mail account. They did not realize that the Notification has to be updated every year. The Notification forms have been sent to Mr. Locke and the Notification will be submitted right after July 4<sup>th</sup>, due to vacation time being taken.
2. Only vegetative debris is to be at site. All unacceptable debris including plastics, etc. are to be removed on a daily basis and disposed of at a permitted facility.
3. There is less than ¼ acre worth of debris at the site.
4. A Yard Waste Notification must be obtained every year by June 1<sup>st</sup>, as long as there vegetative debris still at the site.
