ADDITIONAL COMMENTS

On December 21, 2015, John Patrone met with Tim Friddle to conduct a comprehensive inspection of the W.W. Dick LCID Landfill on Winfree Road in Summerfield, Guilford County.

1. The facility is a land clearing and inert debris (LCID) landfill, known as the Winfree Road Landfill.
2. The facility is in operation Monday through Friday 7:30 am to 5:30 pm.
3. The facility is operating in Phase 2.
4. The facility is permitted to receive waste generated within Alamance, Guilford, and Rockingham Counties.
5. The facility is permitted to receive land clearing waste, yard trash, untreated and unpainted wood, uncontaminated soil, inert debris, and (used) asphalt.
6. Per 15A NCAC 13B .0566(3), "Solid waste shall be restricted to the smallest area feasible and compacted as densely as practical into cells."
7. Per 15A NCAC 13B .0566(4), "Adequate soil cover shall be applied monthly, or when the active area reaches one acre in size, whichever occurs first."
8. The facility operates a long narrow working face. Side slopes are covered with soil.
9. It is recommended that the working face be maintained small.
10. Excavation, grading, and fill material side slopes shall not exceed three to one (3:1).
11. Logs are removed from LCD to cut for firewood.
12. Logs for firewood are stored away from operational areas of the landfill.
13. A ready supply of soil shall be available for cover material.
14. Ensure permanent edge of waste markers are visible.
15. The facility annual report (FAR) was received by the SWS, dated July 13, 2015. Estimated facility throughput for July 2014 through June 2015 is 884 yd³.
16. There was no indication of erosion or runoff.
17. Access roads are of all-weather construction.
18. An attendant is on duty when the facility is in operation.
19. The facility is secured by a locked gate.
20. The facility has a proper sign.
21. The PTO expiration date is November 10, 2015.
22. Mr. Friddle stated that the facility has contacted the SWS regarding permit renewal.
