**ADDITIONAL COMMENTS**

On December 21, 2015, John Patrone met with Mark Doggett to conduct a comprehensive inspection of the Doggett Construction Company, Inc. LCID Landfill on Bishop Road in Greensboro, Guilford County.

1. The facility is a land clearing and inert debris (LCID) landfill.
2. The facility is not open to the public.
3. Mr. Doggett stated that the facility is used by the Doggett Construction Company, Inc. and that it is used infrequently/when work is in the area.
4. The facility is permitted to receive waste generated within Guilford County.
5. The facility is permitted to receive land clearing waste, yard trash, untreated and unpainted wood, uncontaminated soil, inert debris, and (used) asphalt.
6. Per 15A NCAC 13B .0566(3), "Solid waste shall be restricted to the smallest area feasible and compacted as densely as practical into cells."
7. Per 15A NCAC 13B .0566(4), "Adequate soil cover shall be applied monthly, or when the active area reaches one acre in size, whichever occurs first."
8. The working face was of adequate size.
9. Excavation, grading, and fill material side slopes shall not exceed three to one (3:1).
10. A ready supply of soil from the borrow area on the property is available for cover material.
11. The facility stockpiles concrete on the property. Stored concrete is piled until crushed.
12. The facility stockpiles used asphalt to use for road bedding material, etc.
13. Mr. Doggett stated that edge of waste markers will be installed in the coming weeks.
14. The facility annual report (FAR) was received by the SWS, dated July 27, 2015. Estimated facility throughput for July 2014 through June 2015 is 7,800 yd<sup>3</sup>.
15. There was no indication of erosion or runoff.
16. Access roads are of all-weather construction.
17. The facility is secured by a locked gate.
18. The facility has a proper sign.
19. The PTO expiration date is October 8, 2015.
20. Mr. Doggett stated that the facility is in discussion with the SWS regarding permit renewal.
