3. The site is permitted for land application of domestic septage.
4. The site had accessible all-weather road to the septage land application field covered under the permit.
5. Appropriate signage was displayed at the site.



6. The field had disposal area boundaries that were well delineated with permanent markers which corresponded to the site map.
7. All septage discharges appear to have been made within the disposal area boundary. The waste appeared to be evenly distributed throughout the field. No recent septage application were observed.
8. No evidence of standing liquid or pooled waste was observed.
9. No objectionable odors were observed.
10. The southern portion of the field appeared to have a good stand of fescue. The northern portion of the field contained a lot of weeds. Refer to the nutrient management plan for weed control and planting times. Additional information can also be obtained at the Alexander County Cooperative Extension Service at (828) 632-4451.
11. Site logs were not reviewed at this time.
12. Soil samples were collected from the field. The check for soil sampling was received.
