Dear Mr. Whisnant:

We are in receipt of the "Soil Assessment Report" dated October 5, 1993 for the referenced site. The initial tank closure report indicated 40.2 ppm isopropyl acetate at a depth of twenty feet in the area of tank #T1. The report dated October 5, 1993 indicates that isopropyl acetate was not found above detection limit. However, groundwater was identified to be between fifteen and eighteen feet.

Due to the fact that contaminated soils were at one time in or near groundwater, we require that a monitoring well be installed in the area of former soil contamination located around tank #T1. The groundwater sample should be analyzed for isopropyl acetate. The results are due in this office by December 31, 1993.
