Dear Mr. Cordes:

The subject groundwater incident has been transferred to the Division from the Department of Emergency Services. Mrs. Kelly Gage has transferred all pertinent information about this case to me. Any further correspondence should be addressed to me at the letterhead address.

I have thoroughly reviewed the file, and discussed the case with Mrs. Gage. This office has serious doubts as to the claim that the Tetrachloroethene (PCE) found in the groundwater on the subject property is a result of contamination at CIBA. The Comprehensive Site Assessment (CSA), due July 19, 1993, must fully assess the extent of contamination of this constituent. Unless a **direct link** can be made between the Draper contamination, and the CIBA contamination, you must include in your Corrective Action Plan (due 60 days after receipt of CSA or by September 17, 1993; whichever is earliest) the remediation of PCE from the groundwater. For your information, I am assigned to the CIBA case. The groundwater and surface water monitoring results at CIBA and the work submitted by your consultants, do not seem to point at the CIBA incident.

I am currently reviewing your submitted CSA for the former 30,000 gallon #4 fuel oil tank area. Upon completion of my review, I will contact Denny Walker of your office.
