Debbie,

I met with Bhavyesh Shah (property owner) today about upgrading the USTs at the referenced site. I identified at least 1 potable well within 1,000' of the site at 176 Salty Shores Road (930' from leak at pumps), and I believe the house at 150 Salty Shores Road (550') is not connected to the municipal water supply. The attached LSA indicates it is a low risk site; however, I believe you should look at the risk classification. I attached an aerial map showing the locations of the residences on Salty Shores Road.

If this is a high risk site, I advised Bhavyesh that he should cleanup the soils at the dispensers during upgrade. Cary Oil is trying to get Bhavyesh to take ownership of the tanks and all associated environmental liability. I am meeting with Vince Morgan Monday at 11:00 if you want to discuss this.


