Dear Sir or Madam:

On July 1, 2002, this office notified you that our records indicated that you had not paid the annual fee associated with renewal of Monitor and Recovery Well permits for this site.

The Guilford County Board of Health Rules and Regulations Governing the Construction and Abandonment of Monitoring and Recovery Wells Chapter IV under Section I (B) states: **“Monitoring and recovery well permits must be renewed every twelve (12) months from the date of initial issuance for so long as they remain in operation.”**

The renewal well permit fee is **OVERDUE**. If you feel that you have received this invoice in error, please contact: Ms. Janet Fonville, Guilford County Environmental Health, Greensboro, NC 27405, @ (336) 641-3772.

Please also keep in mind that monitor/recovery well renewal payment is required regardless of the incident status of the above referenced site. Essentially, even if the site has been issued an NFA (No Further Action) letter; i.e. deemed closed by the NC DENR, you are still required to pay the annual renewal permit fee if **the monitor and/or recovery wells have not been properly abandoned**. If payment for this referenced site is not submitted to this office by September 1, 2002, this matter will be referred to the County Attorney's office for further action.
