
Dear Mr. Watters:

S&ME, Inc. and our client Unocal Corporation believe that the State priority ranking of 70D for the subject site is incorrect. The site should be re-classified as a B site, given that the adjacent Williams private water well is in use, within 500 feet from the Unocal dissolved hydrocarbon plume and the Williams' residence (1436 Trollingwood Rd.) is not served by an existing public water supply. This was confirmed by S&ME, Inc. during a water well survey on July 16, 1996.

At present, there is an operating air sparge remediation system at the former Unocal site. The site is eligible for reimbursement under the State Commercial Trust Fund. Please contact us regarding your review or possible new ranking of the site. The air sparge system will remain in operation until we here from you or the site is re-classified, at the request of Unocal Corporation. If you have any questions or need additional information, please call.


