WARNING LETTER

On December 18, 1980, the State of North Carolina, Hazardous Waste Section (State) was authorized to operate the State RCRA hazardous waste program under the Solid Waste Management Act (ACT), N.C.G.S. 130A, Article 9 and rules promulgated thereto at 15A NCAC 13A (Rules) in lieu of the federal RCRA program.

On June 12, 2007 Sean Morris, Environmental Senior Specialist, representing the North Carolina Hazardous Waste Section inspected Joel's Garage & Used Parts located in Kannapolis, NC for compliance with North Carolina Hazardous Waste Management Rules. During that investigation, the following violation(s) was noted:

Specifics

1. **40 CFR 279.22 (c)(1), adopted by reference at 15A NCAC 13A .0118**, states that containers and tanks used to store used oil must be labeled with the words "Used Oil".

Joel's Garage & Used Parts is in violation of this regulation in that there was one 250-gallon used oil tank, located next to the garage area, and the tank was not properly labeled with the words "Used Oil".

2. 40 CFR 279.22 (d), adopted by reference at 15A NCAC 13A .0118, states that upon detection of a release of used oil to the environment that is not subject to the requirements of Part 280, subpart F of this chapter and which has occurred after the effective date of the recycled used oil management program in effect in the State in which the release is located, a generator must perform the following steps:


- (1) Stop the release;
- (2) Contain the release of used oil;
- (3) Clean up and manage properly the released used oil and other materials;
- (4) If necessary, repair or replace any leaking used oil storage containers or tanks prior to returning them to service.

Joel's Garage & Used Parts is in violation of this regulation in that there was a small area of oil-contaminated soil located next to the facility's used oil tank. The contaminated soil must be excavated, containerized, and properly disposed.

You are hereby required to comply with the noted violation(s) by July 17, 2007 at which time a follow up visit may be performed. If compliance with the violation(s) noted above is not met, you may be subject to formal enforcement procedures and an administrative penalty may be assessed for violation of the hazardous waste law or regulations.

In further satisfaction of the violation(s) listed above, Joel's Garage & Used Parts shall provide a written certification with supporting documentation on company letterhead confirming the noted compliance schedule has been completed.
