Dear Mr. Lefler:

Marshall Miller & Associates, Inc. (MM&A) has performed an assessment of the above referenced landfill and has found no specific evidence that such a landfill ever existed. This conclusion was based on interviews with the property owners on Pack Road (SR1931) and neighboring roads, and county personnel; review of aerial photographs and historical topographic maps; and deed research.

The Site, reported to be located on SR 1931 off of Highway 311 by the Old Unlined Landfill Inventory Sheet (**Appendix A**) on file at the North Carolina Department of Environmental and Natural Resources (NCDENR), could not be located. Nor was any correspondence or documentation of any kind, including any Land Disposal Site Modification Report, located in the NCDENR file room.

The car junkyard indicated by officials at Stokes County as a potential location was ruled out after interviews with the property owner, Donald Pack. Mr. Pack has lived in the area since 1979 and had no recollection of a dump on his property or any other property along Pack Road.

Nearby residents on neighboring roads to the north and south, some of whom having lived in the area since as early as 1943, likewise recalled no dump or landfill in the area.
