The North Carolina Department of Environment and Natural Resources' Division of Waste Management (State) has been tasked with gathering information and accurately locating pre-regulatory landfills. There are 676 pre-regulatory landfills currently included on a list maintained by the State.

The General Assembly has appropriated funding through Senate Bill 1492 to determine the location of these landfills and identify potential hazards to the public and the environment. We have received notification that your property and/or nearby properties may have been used as a landfill in the past. The State requests permission to inspect your above referenced property to look for the disposal area and the presence of any hazards that may exist because of the property's past use as a landfill.

Marshall Miller and Associates, Inc. has been contracted by the State to perform location research and inspection of these pre-regulatory landfill sites. This inspection is for information gathering purposes only to determine whether the disposal area qualifies as a pre-1983 landfill for our program. By granting permission, you are not assuming responsibility for any hazards found.
