In accordance with Paragraph 24(m) of the Brownfields Agreement (BFA) filed June 2004 between the North Carolina Department of Environment and Natural Resources (DENR) and CNR Properties RLLLP (CNR), for the property located at 4750 South Boulevard, Charlotte, North Carolina (Property), CNR is transmitting this certification of Land Use Restrictions Update for the year 2007.

In completing this certification, the following information was verified:

1. that the Notice of Brownfields Property containing the land use restrictions remains recorded at the Mecklenburg County Register of Deeds office;


