We respectfully request your approval to perform the following scope of work at the above referenced Brownfields site:

- Tear down existing 7200 SF added on structure and concrete slab
- Perform minimal grading to prepare site for new structure
- Construct 12,800 SF new slab on grade structure
- The slab will be protected with a 6 mil poly vapor barrier
- The roof deck (ceiling) height is 23' 3" on the high side, and 16' 7" on the lower side
- Excavated soils will be stored on site

I have included a sketch showing the outline of the structure being demo'd as well as the new structure being erected in its place.

Please let me know if you need anything else with regards to this project.


