THE EVENT OCCURRED IN JULY 2015 AND WAS A PART OF THE DECOMMISSIONING OF THE SITE. BEFORE JULY 2015, THE SITE WAS HISTORICALLY A SQG. JULY 2015 WAS THE ONLY MONTH OF LQG WITH THE REMAINING MONTHS OF 2015 STABLE AT SQG. FINAL HAZWASTE GENERATION WAS NOVEMBER 2015. \*\*\*SITE CONTACT, STATUS\*\*\*
