TARGET STORES NORMALLY OPERATE AS SMALL QUANTITY GENERATORS (SQG) AS DEFINED IN 40 CFR 262.34. HOWEVER, TARGET RETAILS PHARMACEUTICALS AND OVER-THE-COUNTER (OTC) PRODUCTS THAT WHEN SENT OUT AS A WASTE MAY BE CONSIDERED A P-LISTED WASTE. THESE EPISODIC EVENTS MAY EXCEED 2.2 POUNDS IN A SINGLE SHIPMENT. IN DECEMBER 2015, TARGET SOLD ALL PHARMACY OPERATIONS TO CVS HEALTH. TARGET CONTINUES TO RETAIL OTC PRODUCTS THAT MAY CONTINUE TO BE CONSIDERED P-LISTED WASTE.
