Enclosed is a Short Form Compliance Order with Administrative Penalty ("Compliance Order") issued to The Salem Collection for a violation of the North Carolina Solid Waste Management Act, N.C.G.S. Chapter 130A, Article 9 (the "Act"), and the North Carolina Hazardous Waste Management Rules, 15A NCAC 13A (the "Rules"). The Compliance Order describes both the violation and the action required for compliance with the Act and Rules.

The Salem Collection may contest this Compliance Order by filing a written petition for a contested case hearing in accordance with N.C.G.S. 150B-23(a) and 150B-23.2. See the section entitled "Notice of Rights to a Contested Case" in the attached Compliance Order.

Please be advised that the Department of Environment and Natural Resources has implemented a department-wide policy to release all penalties assessed against facilities to the media. Therefore, the name of your company and the penalty amount that has been assessed against the facility may be released to the media.

If no contested case petition is filed, the administrative penalty must be paid by The Salem Collection within forty-five (45) days of receipt of the Compliance Order. Payment should be made by certified check or money order, payable to the Division of Waste Management, and mailed to:

7. As of the date of this Compliance Order, The Salem Collection has not paid its annual fee for state fiscal year 2008.

ADMINISTRATIVE PENALTY

N.C.G.S. 130A-22(a) authorizes an administrative penalty of up to \$32,500.00 per day for each violation of the hazardous waste provisions of the Act, Rules or any order issued pursuant to the hazardous waste provisions of the Act. N.C.G.S. 130A-22(d) sets forth the factors to be considered in determining the administrative penalty which include the degree and extent of the harm caused by the violation and the cost of rectifying the damage.

15A NCAC 13B .0702 sets forth specific criteria to be considered in addressing the statutory assessment factors which include the type of violation, type of waste involved, duration of the violation, cause of the violation, potential effect on public health and the environment, effectiveness of response measures taken by the violator, damage to private property and the history of non-compliance.

After careful consideration of each factor above, a penalty is assessed in the amount of \$440.00.

CONDITIONS FOR CONTINUED OPERATION

Based on the foregoing, The Salem Collection is hereby ordered to take the following actions:

1. Within forty-five (45) days submit the amount of the administrative penalty of \$440.00 and a late payment fee of \$12.50 for a total of \$452.50, by certified check or money order, and payable to the Division of Waste Management. The payment should be mailed to:

2. Within forty-five (45) days submit the past due annual fee in the amount of \$125.00, for the year 2008 by certified check or money order and payable to the Division of Waste Management. The payment should be mailed to:

3. No penalty is assessed at this time for the 2009 annual hazardous waste fee of \$125.00 that has not yet been paid. In order to avoid an additional penalty for failure to pay the 2009 fee it must be paid by June 30, 2010. However, if you wish to come into full compliance at this time, the check or money order required under paragraph 2 above should be for \$250.00. (Note that the enclosed invoice does not include the \$440.00 penalty.)

POTENTIAL CONSEQUENCES OF FAILURE TO COMPLY

The Salem Collection is hereby advised that, pursuant to N.C.G.S. 130A-22, each day of continued violation of any requirement of the Act or the Rules constitutes a separate violation for which an additional penalty of up to \$32,500.00 per day may be imposed. If the violation continues The Salem Collection may also be subject to further enforcement, including injunctive action, to prohibit any further generation of hazardous waste and such further relief as may be necessary to achieve compliance with the Act and Rules.

NOTICE OF RIGHT TO FILE CONTESTED CASE PETITION

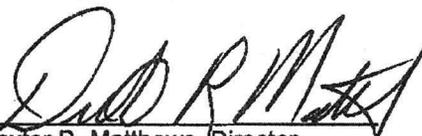
The Salem Collection has the right to file a contested case petition regarding a matter of law, material fact, requirement, or the penalty set forth in this Compliance Order as allowed by N.C.G.S. 150B-23. Any petition for a contested case hearing must be filed with the Office of Administrative Hearings, 6714 Mail Service Center, Raleigh, NC 27699-6714, along with the appropriate filing fee set by the Office of Administrative Hearings in accordance with N.C.G.S. 150B-23.2, within thirty (30) days of receipt of the Compliance Order. A copy of the petition for a contested case hearing must also be served on the Division by sending a copy of the petition to:

Additional information concerning the Office of Administrative Hearings, filing fees for a contested case petition and the appeal process may be found on the official website for the Office of Administrative Hearings, located at www.oah.state.nc.us or by calling (919) 431-3000.

If a petition for contested case is not timely filed with the Office of Administrative Hearings and served on the Department, payment of the administrative penalty becomes due within forty-five (45) days after receipt of the Compliance Order. If a contested case petition is timely filed and served, payment of the administrative penalty is due within 60 days of receipt of a written copy of the final agency decision. If payment is not received as required, the Secretary of the Department of Environment and Natural Resources shall request the Attorney General to commence a civil action in Superior Court to recover the amount of the administrative penalty.

Who is Required to Pay?

BY **LAW** you are required to pay the fee(s) when your company has notified that it is a generator, transporter, treater, storer or disposer of hazardous waste as defined below.

Large Quantity Generator (\$1,000.00): A facility who generates one kilogram or more of acute hazardous waste or 1,000 kilograms or more of hazardous waste in any calendar month during the year beginning July 1 and ending June 30. Large Quantity Generators are also required to pay an additional fee of \$0.50 per ton, or any part thereof, for hazardous waste generated during the calendar year up to a maximum of 25,000 tons. [Note: Large Quantity Generators must determine how much waste was generated in the 2008 calendar year. The calculated tonnage should be entered in the table located on the front of this invoice under the column heading *Facility Status* and in the *Waste Generation* row. To calculate the amount due, multiply the amount generated by \$0.50 and enter in the *Amount Due* column for Waste Generation. Total all the fees in the *Amount Due* column for the *Total Amount Due*.]

Small Quantity Generator (\$125.00): A facility who generates 100 kilograms or more of hazardous waste but less than 1,000 kilograms in any calendar month during the year beginning July 1 and ending June 30.

Transporter (\$600.00): A facility that transports hazardous waste.

Treater, Storer or Disposer (\$1,200.00 each): A treatment, storage, or disposal facility shall pay an annual activity fee for each activity. (Note: A commercial hazardous waste storage, treatment, or disposal facility is also required to pay an additional fee of \$1.75 per ton, or any part thereof of hazardous waste stored, treated, or disposed of at the facility) during the 2009 calendar year.

Dear Mr. Caudill,

Thank you for the invoice copy. I pulled my correspondence on the issue.

My records indicate that this invoice had been addressed on November 22, 2010. I talked with a Ms. Cotto concerning the legal dissolution of J.R. Craver & Associates, Inc d/b/a The Salem Collection. The corporation was legally ended on December 29, 2009 and documents to that fact are on public record in Raleigh.

Ms. Cotton's ext. is 8537. I do not understand why Aljon Properties, LLC would have been involved in this situation as they merely owned the real estate that was leased by J.R. Craver & Assoc., Inc.

Personally, I was the president of the company until it was dissolved in 2009. The handling and reporting of hazardous waste was handled by the VP of manufacturing. The company was a very small generator of waste and to my knowledge all issues were in order.

Our accounts payable department would have handled any billing from NCDENR. Our checks were normal originated and signed electronically . That is all I can tell you about the situation.

The company was dissolved and NewBridge bank foreclosed on Aljon Properties, LLC.'s real estate holdings . I have since started a small business with my wife but am semi-retired and on social security. I also had a heart attack in 2007 and in addition had to endure the stress of the bank destroying our 25 year family business. With over 100 employees at the time of closure, my family paid millions in taxes to the federal, state, and local government. Property taxes alone were over one million dollars.

As I told Ms. Cotton, I am sorry for any loss the State may have incurred because of the actions of the bank against our company, but they walked away with millions more in assets than we owed. They left us with very little.

Currently I remain in poor health with a heart condition. Since I have already addressed this issue with Ms. Cotton in detail, I would appreciate the State's understanding of my personal situation and health problems. I'm sorry I can't be more help but "it is what it is". Hopefully the State can close it's file on this issue and we can move on.
