4. All septage discharges appeared to be within the permitted boundaries of the site.
5. No spot dumps or thick applications noticed.
6. The ryegrass needs to be removed off of Fields 1, 2, and 3. Ryegrass over 12 inches in height.
7. pH not checked. No application at time of inspection.
8. No objectionable odors noticed today.
9. No change noticed that would affect setback distance.
10. Permit application, nutrient management plan, and records under review for permit renewal.
11. Ryegrass needs to be removed off of Fields 1, 2, and 3.
