**RE: Closure Notification of Permit # SDTF-27-08 and Permit # SLAS-27-08
Eddie Younts Septic Tank Service
SR 1118 in Currituck County**

Dear Mr. Younts:

The Division of Waste Management has closed out **Permit #SDTF-27-08** that was issued to you for the operation of a septage detention facility in Currituck County off of SR 1118. On April 7, 2016, the Division received an email from Atlantic OBX Inc. which contain a letter confirming that they had purchased the business and the land for which the septage detention facility was located. Atlantic OBX Inc. has applied for a permit to operate this facility. Therefore, the Division has closed out **Permit #SDTF-27-08** with you as the permittee/operator.

Also, The Division of Waste Management has closed out **Permit #SLAS-27-08** that was issued to you for the operation of a septage land application site off of SR 1118 in Currituck County. On April 7, 2016, the Division received an email from Atlantic OBX Inc. which contain a letter confirming that they had purchased the business and the land for which the septage land application site was located. Atlantic OBX Inc. is in the process of applying for a permit to operate this septage land application site. Therefore, the Division has closed out **Permit #SLAS-27-08** with you as the permittee/operator.

Remember that the storage or land application of septage on sites that are not permitted can result in administrative penalties of up to \$15,000 per violation per day in accordance with NC General Statute 130A-22.
