DAIKIN APPLIED ACTS AS THE LEGACY PROPERTY OWNER RESPONSIBLE FOR THE CORRECTIVE ACTIONS RELATED TO A RELEASE OF CHLORINATED SOLVENT TO SOIL AND GROUNDWATER ON THE PROPERTY PRIOR TO 1988. THE CURRENT OWNER, PORT CITY LLC IS NOT RESPONSIBLE FOR THE ENVIRONMENTAL CORRECTIVE ACTIONS ON THE PROPERTY AND DOES NOT USE ANY SOLVENTS FOR THEIR CURRENT MANUFACTURING PROCESS (PACKING AND CRATING SUPPLIES). HAZARDOUS WASTES ARE NOT ROUTINELY GENERATED AT THE PROPERTY, ONLY VERY SMALL QUANTITIES OF SEDIMENTS FROM TREATMENT SYSTEM CLEANING AND FOR SKIMMED HYDROCARBONS (ALSO LOW QUANTITIES) FROM HISTORIC RELEASES. ***NAICS CODE, SITE CONTACT PERSON, MAILING ADDRESS, WASTE CODES***
