4. The site had accessible all-weather road to the septage land application field covered under the permit.
5. Appropriate signage was displayed at the site.
6. The field had disposal area boundaries that were well delineated with permanent markers which corresponded to the site map.
7. No recent septage application were observed.
8. No evidence of standing liquid or pooled waste was observed.
9. No objectionable odors were observed.
10. The field appeared to have not been harvested for some time. The hay will need to be harvested before additional land application is done.
