Good afternoon Mr. Mattison,

Please accept this as the situation report for the LCP Holtrachem site as of about 1:30 pm this afternoon.

As of the 11 am National Hurricane Center interim update, the projected path of Hurricane Matthew has remained similar to prior forecasts. The projection indicates the hurricane will skirt the Central Florida coast before turning to the north, and then northeast, with the center of the storm projected to be well offshore coastal North Carolina. However, the Riegelwood area is still just within the cone of potential paths.

Currently the predicted rainfall amounts have remained consistent for the coastal North Carolina area. They currently are: 1.5" on Friday (1.2" already fallen onsite); 7.4" on Saturday; 0.02" on Sunday.

Emergency preparations are in effect at the site. We continue to operate the treatment system today until 11:00 pm. Local personnel will then check on the plant Saturday morning to determine the onsite conditions. Current pond freeboard levels are as follows:

South Pond – 4' (pond basically empty)
North Pond - 11'+

Based on the predicted rainfall amounts and current operations, no emergency actions are required at this time.

GES and/or Amec Foster Wheeler will continue to provide status updates until we're confident that this system will not impact the site.

At this time, we do not think that we need to engage International Paper to assist with water discharge. However, if conditions deteriorate we will begin that notification process with Samantha. Initial contact has been made with International Paper personnel regarding our status and they have been included in this update and will be included in future updates.

The next update will be tomorrow morning by 8:00 am.

As of the 2 am National Hurricane Center interim update, the projected path of Hurricane Matthew has remained similar to prior forecasts. The projection indicates the hurricane will skirt the Central Florida coast before turning to the north, and then northeast, with the center of the storm projected to be well offshore coastal North Carolina. However, the Riegelwood area is still just within the cone of potential paths.

Currently the predicted rainfall amounts have slightly decreased for the coastal North Carolina area. They currently are: 1.4" on Friday (1.2" already fallen onsite); 7.9" on Saturday; 0.06" on Sunday.

Emergency preparations are in effect at the site. We continue to operate the treatment system today until 11:00 pm. Local personnel will then check on the plant Saturday morning to determine the onsite conditions. Current pond freeboard levels are as follows:

South Pond – 4' (pond basically empty)
North Pond - 11'+

As of 8am today, the projected path of Hurricane Matthew has remained similar to yesterday evening's projection. The projection indicates the hurricane will skirt the Central Florida coast before turning to the north , then northeast, with the center of the storm projected to be well offshore coastal North Carolina. However, the Riegelwood area is still just within the cone of potential paths.

Currently the predicted rainfall amounts have increased for the coastal North Carolina. They include: 0.5" on Thursday; 2.5" on Friday; 9" on Saturday; <0.1" on Sunday.

Emergency preparations are in effect at the site. We continue to operate the treatment system on a 24-hr basis. Current pond freeboard levels are as follows:

South Pond – 4' (pond basically empty)

North Pond - 10'+

Based on the predicted rainfall amounts and current operations, no emergency actions are required at this time.

Per our recent conversation and the email below, we will provide you and the team with an update of our site conditions twice a day. We'll try to update everyone around 0800 & 1400.

As of 2 pm, the projected path of Hurricane Mathew does not indicate hurricane force winds and associated heavy rains will impact the Riegelwood site. Currently the predicted rainfall amounts include: <1-in on Thursday; 3.5-in on Friday; 3-in on Saturday; <0.5-in on Sunday.

Emergency preparations are in effect at the site. As discussed in a previous email from Greg, they are operating the treatment system on a 24-hr basis. Based on the predicted rainfall amounts and current operations, no emergency actions are required at this time.

GES and or Amec Foster Wheeler will continue to provide status updates until we're confident that this system will not impact the site.

At this time, we do not think that we need to engage International Paper to assist with water discharge. However, if conditions deteriorate we will begin that notification process with Samantha.

Folks,

The department is requesting PIOs send situation reports (sit reps) twice a day starting tomorrow for the response to Hurricane Matthew.

Please send to me sit reps from your programs or sections by 8:30 a.m. and 2:30 p.m. each day. I will have 30 minutes to edit them and send them to the department brass.

We will continue with sit reps each day, until we are notified otherwise.

From 3 p.m.-11 p.m. Friday and Saturday, I'm scheduled to work at State Emergency Operations Center. During my shift, I will be unable to manage our sit reps. However, Cathy Akroyd (Friday afternoon) and Sarah Young (Saturday afternoon) have agreed to gather, edit and send along Friday and Saturday afternoon sit reps from staff in DWM and DEACS. I will be able to handle the sit reps for the two programs for Friday and Saturday morning, and the rest of the time sit reps are needed. Throughout the incident, please send your sit rep information to Jamie.Kritzer@ncdenr.gov, Cathy.Akroyd@ncdenr.gov and Sarah.Young@ncdenr.gov. That way, we'll all be in the loop throughout the incident, in case there are media or other information needs.

In the past, we've used a structured template for the sit reps. However, please us with your information in bullet points. Please include information about what your staff or programs are doing to prepare for or respond to the storm (protecting state equipment, vehicles, buildings, and our work to help the people we regulate and serve with preparation and response/recovery). These sit reps are a good way to keep everyone informed of all the great work we do as an agency and frequently are included in press briefings provided by the governor and his staff. So they are really serve a useful function.

Most of the recent forecast models show Hurricane Matthew taking a more eastward track and moving away from the North Carolina coast (<http://www.wral.com/dramatic-forecast-track-change-pushes-matthew-farther-off-nc-coast/16084603/>).

Let's hope the models are accurate. But please be safe. Best to plan for the worst and hope for the best.

Should this schedule change, I will send you an email letting you know.
