The purpose of this letter is to provide Initial Notification to the North Carolina Division of Waste Management (NC DWM) for the above referenced facility. Metropolitan Woodworks, Inc. (Metropolitan) has prepared the enclosed EPA Form 8700-12 to notify the NC DWM of regulated waste activity (expected to be SQG) and to obtain an EPA ID number.

Metropolitan will be manufacturing kitchen cabinetry, vanities, and mouldings at the referenced facility. Operations include application of solvent based stain, sealer and topcoat to cabinetry and associated components. Application of finishes will be in three spray booths located at the facility. Waste generated from the finishing operations will be managed and disposed as hazardous waste. The facility is expected to generate small quantities of Universal Waste (fluorescent light bulbs, used/waste oil) that will be managed properly.
