AECOM is pleased to submit this quarterly letter status report, due in April 2015, to summarize work performed this past quarter at the above-referenced site. We are also transmitting the RI Work Plan (RIWP) Addendum for Off-Site Groundwater, an additional scope which we will soon initiate. In summary, the work completed this past quarter includes further development of the draft Remedial Investigation (RI) Report, site visit to plan the off-site assessment, on site and telephone discussions with the NC Department of Transportation (NCDOT) personnel, and development of this RIWP Addendum being transmitted with this letter. This quarterly status report confirms that work is progressing in a manner to achieve the mandatory work phase completion deadlines set out in 15A NCAC 13C .0302(h). Field activities to implement the work plan addendum are anticipated to begin soon.
