On behalf of the North Carolina Department of Environment and Natural Resources (NCDENR), Division of Waste Management, Inactive Hazardous Sites Branch, Superfund Section, Marshall Miller & Associates, Inc. (MM&A) performed a preliminary investigation of an old landfill site identified as the Enfield Drive Rubble Site (No State ID Assigned). The investigation determined that the referenced Site had never accepted municipal or household waste, but had been utilized as a dump for construction, tree, and limb debris. As such, additional work under the Inactive Hazardous Sites Branch, Old Unlined Landfill Program is not necessary. For your records, the following is a synopsis of the information collected to date.

Two letters dated May 11, 1979, from Terry F. Dover, Eastern Program Supervisor, Solid & Hazardous Waste Management Program to Mr. Carl George and Rev. Thomas Elwood Davis were identified during review of historical files for Durham County. These letters indicate that a "solid waste disposal site" was operated at the end of Enfield Drive in a flood plain area of a branch of Northeast Creek. The letter addressed to Rev. Davis states that the Site must be closed by July 9, 1979. These letters are included as *Historical Correspondence* in **Attachment A**.

Subsequent interviews with local, long-term residents of Enfield Drive revealed that the Site had been used as a dump for construction debris, trees, and stumps. Mr. Albert Walker of 2710 Enfield Drive stated that the Site had only accepted trees, stumps, old brick, and cement, but never any municipal or household waste. There is currently a mobile home located on the Site which Mr. Walker stated was "moved in" in 1988 or 1989. *Records of Communication* are included as **Attachment B**.





Dear Rev. Davis:

This letter confirms the meeting Mr. Andrew Robinson, District Sanitarian, and I had with you on Tuesday, May 8, 1979. The subject of our meeting was the closeout of your rubble site which is located at the end of Enfield Drive, Durham, N. C.

As was relayed to you, your site must be closed due to the fact that you are depositing solid waste in a flood plain area of a branch of North-east Creek. This area was so designated by the soil survey of Durham County which was completed in 1969 by the U. S. Soil Conservation Service.

The following close-out requirements must be completed by July 9, 1979:

1. Implement effective rat control including baiting for at least two weeks to prevent rat migration to adjacent property.
2. Compact and cover existing solid waste on site with at least two feet or more of suitable compacted earth.
3. Implement erosion control measures by grading and seeding.
4. Post signs indicating the dump site is closed.


It was further understood that you will have to re-channel the branch around the solid waste because of the present blockage by your site of the branch.

Mr. Montague does not specifically remember any dumping, though he was away during the time the complaint was made and subsequent action taken. He suspects that dumping could have occurred in a low area which was dug out and on top of which a home was built. Mr. Montague currently owns three lots which formerly belonged to Rev. Davis (Former owner of the Site).</p> <p>Mr. Montague suggested contacting Gloria Lowe, who operates a hair salon from her home, as she "knows everything" about the area. And "If she doesn't know, she will know who does."</p> <p>Alternatively, James Wayne may know, though his health is not great.</p> <p>Mr. Montague indicated that he would locate contact information for these two individuals and call back. -JH</p>
