Dear Mr. Latta:

On February 22, 1996, I conducted a site visit at the Midland Terrace LCID Landfill, Permit #32-H, in Durham County, North Carolina. During my visit I noted that the facility had received several loads of building demolition debris that I understand was generated by a demolition project at North Hills Mall in Raleigh, N.C.

In addition to the concrete rubble in these loads, I observed more-than-incidental amounts unpermitted wastes, including metals, painted and/or treated wood, foam products, and pieces of carpet and rubber mats. Although it appeared that an attempt was made at the demolition site to segregate the concrete rubble from the other (unpermitted) debris, the waste from this project that I observed at your landfill could not be considered clean wood and inert debris because it contained unpermitted waste types. I brought this to the attention of Mr. Donald Tilley, landfill attendant, who explained that he was in the process of removing the unpermitted wastes from the rubble; he also said that your associate, Mr. Onzlow Painter, had approved the disposal of this demolition debris at your facility.

I returned to the landfill on February 28, 1995 and inspected the remainder of this debris. Although the rubble was "cleaner" than it had been initially, some pieces of unpermitted waste were still visible in the debris. In my opinion, this type of mixed demolition waste, although mostly concrete, contains too much unpermitted waste to meet the intent of 15A N.C. Admin. Code 13B .0566(2), which states that "**the facility shall only accept those wastes which it is permitted to receive.**"

The purpose of this letter is to warn Midland Terrace LCID Landfill to cease accepting mixed loads of building demolition debris, so as to keep this facility in compliance with the North Carolina Solid Waste Management Rules, codified at 15A N.C. Admin. Code 13B.

Also, Mr. Tilley asked again about unpermitted wastes which may arrive unbeknownst to the site operator (e.g., hidden under loads of "clean" waste). Unpermitted waste that arrives at the site should be addressed immediately in the following manner:

1. Any unpermitted waste which arrives at the facility should be segregated from permitted wastes in an area well away from the disposal area as soon as they are noticed, preferably stored in a dumpster or other suitable container;
2. Segregated unpermitted wastes should be removed from the site for proper disposal on a regular basis, at least weekly.

Please remember that pursuant to N.C.G.S. 130A-22(a) and to 15A N.C. Admin. Code 13B .0701 - .0707, an administrative penalty of up to \$5,000.00 per day may be assessed for violations of the North Carolina Solid Waste Management Laws or Regulations. Thank you for your cooperation.



Dear Ms. Walker:

Pursuant to North Carolina General Statutes 130A-22(a) and to 15A North Carolina Administrative Code 13B, you are hereby informed that D.H. Griffin Wrecking Co., Inc. is in violation of the North Carolina Solid Waste Management Rules, codified at 15A N.C. Admin. Code 13B.

On November 13, 1995, I conducted an inspection of the Midland Terrace LCID Landfill, Permit #32-H, in Durham County, North Carolina. During the inspection I observed a truck and trailer belonging to D.H. Griffin Wrecking Co., Inc. dump a load containing wastes which are not permitted to be received at this landfill. The driver of the truck indicated that this waste was generated by demolition of the Cricket Inn on Hillandale Road, for which D.H. Griffin Wrecking Co. is the demolition contractor. Wastes observed at the Midland Terrace site, which were delivered to the site by D.H. Griffin Wrecking Co., Inc., included: painted wood, plywood, linoleum flooring, sheet metals, metal pipe, fiberglass insulation, roofing material, vinyl siding, rubber mats, carpet, electrical conduit, books, and other miscellaneous demolition wastes.

The transport and delivery of this unpermitted waste to the Midland Terrace LCID Landfill constitutes a violation of the North Carolina Solid Waste Management Rules, codified at 15A N.C. Admin. Code 13B; specifically:

15A N.C. Admin. Code 13B .0105 (b) states that **"the solid waste collector shall transport to a site or facility only those solid wastes which the site or facility is permitted to receive."**

Based on the foregoing, D.H. Griffin Wrecking Co. Inc. is hereby directed to take the following actions within 10 days of receipt of this letter to correct the violation stated in this Notice of Violation, and otherwise be in compliance with the North Carolina Solid Waste Management Rules, codified at 15A N.C. Admin. Code 13B:

- I. Comply with 15A N.C. Admin. Code 13B .0105 (b) by removing all unpermitted waste which was transported to the Midland Terrace LCID Landfill;
- II. Properly dispose of this and any other waste generated by the demolition project at a facility permitted or otherwise approved by the Division;
- III. As documentation that the unpermitted waste was disposed of properly, mail copies of all landfill receipts to:
