COMPLIANCE ORDER

PRELIMINARY STATEMENT

This Compliance Order is issued under N.C. General Statutes 130A-22, the Solid Waste Management Act (N.C.G.S. 130A, Article 9), and the Solid Waste Management Rules (15A N.C. Admin. Code 13B). Title 15A of the N.C. Admin. Code, Chapter 13B contains standards and requirements applicable to the proper management of solid waste.

On March 1, 1971, the State of North Carolina, Department of Human Resources, Division of Health Services, Solid Waste Section, implemented a Solid Waste Management Program under the Solid Waste Management Act, N.C.G.S. 130A, Article 9 and Rules codified at 15A N.C. Admin. Code 13B. Solid Waste Management is now regulated under the Solid Waste Section of the Division of Waste Management of the Department of Environment and Natural Resources. Mr. Paul S. Crissman, Chief of the Solid Waste Section, Division of Waste Management, Department of Environment and Natural Resources, has been delegated the authority to implement both the Act and the Rules. Based upon information available, the Division has determined that Eno River Association is in violation of certain requirements of the Act and/or Rules, as set forth below.

STATEMENT OF FACTS

1. On July 1, 1999, the Division of Waste Management issued a permit to operate a Small Type 3 Solid Waste Compost Facility (Permit #32-13) to Eno River Association, located at West Point on the Eno City Park in Durham, North Carolina, Durham County. Permit #3213 Condition No. 10 states, "This permit shall expire on **July 1, 2004**. Changes in ownership, capacity, or receiving additional feedstocks shall require a permit notification." No renewal application was received by the Solid Waste Section.
2. On November 9, 2006, Ms. Mary Whaley, Waste Management Specialist, Solid Waste Section, spoke with Mr. Greg Ball, of Eno River Association. Mr. Ball told Ms. Whaley, that the facility only operates one to three days per year for the Eno River Festival and they did not realize they the permit had expired.

STATEMENT OF VIOLATIONS

The above facts constitute violations of the following sections of Title 15A N.C. Admin. Code Subchapter 13B:

1. Section .0201(a) states that:

No person shall establish or allow to be established on his land, a solid waste management facility, or otherwise treat, store, or dispose of solid waste unless a permit for the facility has been obtained from the Division.

Eno River Association is in violation of *15A NCAC 13B .0201(a)* in that they operated a solid waste management facility without a valid permit.

CONDITIONS FOR COMPLIANCE

Upon receipt of this Compliance Order, you must:

1. Immediately cease accepting all solid waste materials, or
2. Within 30 days submit a permit application to:

POTENTIAL CONSEQUENCES OF FAILURE TO COMPLY


You are hereby advised that, pursuant to N.C.G.S. 130A-22, each day of continued violation of any requirement of the act, the rules, or any order issued under the act or rules constitutes a separate violation for which a penalty of up to \$5,000.00 per day may be imposed. If the violation(s) continue, you may also be subject to further enforcement actions including injunction from operation of a solid waste management facility or a solid waste collection service and any such further relief as may be necessary to achieve compliance with the North Carolina Solid Waste Management Act and Rules.
