Dear Mr. Gilreath:

Based on a site inspection conducted by Solid Waste Section personnel on January 23, 2009, this closure letter acknowledges that the referenced inactive facility must be closed in accordance with the conditions of 15A North Carolina Administrative Code (NCAC) Subchapter 13B .0510 and .0566 of the Solid Waste Management Rules. Section .0510(d) states that when a disposal site/facility has been closed any future disposal operations will require a new permit. Any activities not associated with the maintenance or monitoring of the closed site/facility may be viewed as operation of the facility, therefore violating North Carolina Solid Waste Management Rules.

The landfill must be closed in accordance with 15A NCAC Subchapter 13B .0566(5) as landfill operations have been discontinued. In order to complete closure, within 60 days of receipt of this letter, a landowner notification of compliance letter (see No. 2) and a certified copy of the attached closure letter (see No. 3) must be submitted to this office as required by the following Post-Closure Maintenance Conditions.

### Post-Closure Maintenance Conditions:

Post-closure maintenance and monitoring for this facility shall consist of whatever measures, procedures, and activities are required to maintain this facility in compliance with the following closure conditions specified below. More specific closure conditions, in addition to Sections .0510 and .0566, for this facility include:

1. Closure, in accordance with the "Operational Requirements for Landfills" Section .0566, unless otherwise specified in the permit for this facility is as follows:
  - (a) Final cover of one foot shall be maintained for this facility;
  - (b) Permanent erosion control measures shall be maintained;
  - (c) Drainage control measures shall be implemented, as part of site maintenance, necessary to prevent the impoundment of surface water over the disposal area or the infiltration of surface water into the waste at the facility (this is commonly achieved with slopes having no greater than a 3:1 ratio);

- (d) Temporary seeding, covered with straw and tacking or similar material if necessary, to prevent erosion in the event of site maintenance involving earthmoving activities;
  - (e) Vegetation consisting of native grasses or combination of grasses to promote a year round vegetative cover shall be maintained;
2. Provide (to this office) written notification of compliance by the landowner that the facility complies with the post-closure conditions stated in this letter and that the landowner will comply with the conditions of this closure letter. If the Land Clearing and Inert Debris Landfill has never operated write that in the notification of compliance letter. Ensure that the notification of compliance letter is signed and dated by the landowner and all parties involved.
  3. Information has been provided that a Land Clearing and Inert Debris (LCID) Landfill Notification has been recorded with the Register of Deeds office in Wilkes County for the subject property: Book: 0798, Page: 0504, Filed: July 9, 1998, Notification/Permit issued to Jerry Gilreath.

The attached copy of the closure letter shall be recorded and certified by the Register of Deeds and indexed in the grantor index under the name of the land owner for the property identified by deed located in BOOK: 526 and PAGE: 17. The certified copy of the closure letter affixed with the Register's seal and the date, book, and page number of the recording shall be returned, along with the (signed) notification of compliance letter, to the Solid Waste Section at the following address:
