On behalf of Duke Energy, Inc. (Duke Energy), S&ME, Inc. (S&ME) is providing hydrogen sulfide (H<sub>2</sub>S) monitoring data for the Marshall Steam Station (MSS) Flue Gas Desulfurization (FGD) Landfill located in Terrell, North Carolina. This data is being provided in accordance with the facility's Permit to Operate.

On September 9, 2009, H<sub>2</sub>S measurements were obtained from the two leachate collection clean-out pipes located on the northwest side of the landfill. The sample locations are indicated on **Figure 1**. The measurements were taken by Duke Energy personnel using an Industrial Scientific Corp./ITX Multi-Gas Monitor that was calibrated for the detection of H<sub>2</sub>S in the concentration range of 0 to 999 parts per million (ppm).

H<sub>2</sub>S was not detected in either pipe; both measurements exhibited H<sub>2</sub>S concentrations of 0 ppm. The field data sheets for the sampling event are attached. The data suggests that H<sub>2</sub>S is not being generated by the material stored in the landfill. The next hydrogen sulfide monitoring event will be conducted in March 2009.


