I spoke with Elizabeth Werner earlier this morning and confirmed that overdrilling will not be required as part of abandonment procedures for MW-17, MW-8S, & MW-8D. Abandonment will consist of removal of the well heads to ground surface including the concrete collar around MW-17, removal/disposal of the stickup enclosure for MW-17, and tremie grouting of the respective well casings.
