**ADMINISTRATIVE CONSENT
AGREEMENT AND SETTLEMENT**

The North Carolina Department of Environment and Natural Resources (DENR) through its Division of Waste Management, Solid Waste Section, and WRB Rentals, Inc. hereby enter into this Administrative Consent Agreement and Settlement in order to amicably resolve matters which arise out of a Compliance Order with Administrative Penalty issued by the Division to WRB Rentals Inc. c/o Mr. Wayne R. Brown on February 29, 2008. The Division issued this Compliance Order with Administrative Penalty in the amount of \$8,250.00 pursuant to the North Carolina Solid Waste Management Act, and the rules which implement the act, for violation of 15A N.C.A.C. 13B .0819(a), plus investigative costs pursuant to N.C.G.S. 130A-22(j) in the amount of \$411.61, for a total penalty of \$8661.61, more specifically described in the Compliance Order.

WRB Rentals, Inc. did not file a petition for a contested case hearing pursuant to N.C.G.S. 130A-22(e). The February 29, 2008 Compliance Order with Administrative Penalty constitutes a final agency decision. Accordingly, the allegations and the violations therein are deemed admitted, conclusive, and final and the penalty amount is now due. DENR is authorized pursuant to N.C.G.S. 130A-22(a) and (g)(1) to recover the penalty amount by instituting a civil action in superior court. In order to avoid litigation and to resolve the unpaid penalty, the Division and WRB Rentals, Inc. agree to the following settlement:

A. On March 21, 2008, WRB Rentals, Inc. remitted a check payable to DENR in the amount of \$7,795.61. The Division agrees to accept the sum of Seven Thousand Seven Hundred Ninety-five Dollars and Sixty-one Cents (\$7,795.61), in full settlement of the \$8,661.61 total penalty levied with the Compliance Order.

B. For purposes of Article 3A of Chapter 105 of the N.C. General Statutes, DENR will find that this was a "violation" and will report the violation to the N.C. Department of Revenue, and WRB Rentals, Inc. will not be eligible for such credits.


C. Nothing in this Agreement shall restrict the right of DENR, the Division, or the Solid Waste Section to initiate any action against WRB Rentals, Inc. for any new or other violation of the North Carolina Solid Waste Management Act, N.C.G.S. Chapter 130A, Article 9, the North Carolina Solid Waste Management Rules, 15A N.C.A.C. Chapter 13B, or any other law or rule implemented or administered by DENR.

D. The parties irrevocably waive any right to appeal from this Agreement, assuming such right exists, except that either party may, at its option, seek judicial intervention to enforce the terms of this Agreement.

E. The parties agree and acknowledge that this Agreement sets forth all terms and conditions between them concerning the subject matter of this Agreement, and that there are no terms or conditions between the parties except as specifically set forth herein.

F. This Agreement is effective on the last date that any signatory to the Agreement shall affix his or her signature.




