The Solid Waste Section has prepared draft Solid Waste Permit Number 54-03 allowing the Lenoir County Construction and Demolition Debris Landfill (C&DLF) to continue operations of Phases 1, 2 & 3 pursuant to the North Carolina Solid Waste Management Rules, 15A NCAC 13B .0547(4). The C&DLF, owned and operated by Lenoir County, is located at 2949 Hodges Farm Road, La Grange, North Carolina 28551. It encompasses an approximately 18-acre waste footprint. The C&DLF unit is seated on top of the closed 47-acre Municipal Solid Waste Landfill (MSWLF) and has a gross capacity for waste disposal of 1,126,540 cubic yards. The draft permit also includes conditions for operating miscellaneous waste management units at the facility.


Impact to groundwater from the closed, unlined MSWLF requires the implementation of a corrective action plan. An assessment of corrective measures for groundwater treatment was presented at the public meeting held on March 26, 2008. Monitored natural attenuation was the selected remedy. The remedy will combine the existing institutional controls, capping for the source control, and a passive gas venting system to control decomposition gases. The draft permit contains conditions for the implementation, operation, and assessment of the corrective action plan.

North Carolina Solid Waste Management Rules require that the general public be given a 45-day period to comment on this draft permit. The comment period will begin on January 28, 2012, and end at 5:00 PM on March 12, 2012. Comments should be submitted in writing to Ming-Tai Chao, division contact, at the address listed above. All data submitted by the applicant, fact sheet, and draft permit are available as part of the administrative record and may be reviewed during business hours (9 a.m. - 4 p.m., Monday-Friday, by appointment) at the Division of Waste Management offices, located at 217 West Jones Street, Raleigh, North Carolina. A public hearing has not been scheduled for this draft permit. Any person interested in a public hearing on this draft permit should notify the division contact. If sufficient interest exists, a public hearing will be scheduled.
