Thank you for your query. Information submitted for the permit has been reviewed. However, additional information is needed to complete writing of the permit. Please provide the information listed below:

1. volume (in cubic yards) of waste in existing Phases 1, 2, and 3
2. volume (in cubic yards) of proposed additional waste for Phases 1, 2, and 3
3. volume (in cubic yards) of total gross capacity of waste at the landfill

In addition to volumes, please submit the following:

1. acreage of existing Phases 1, 2, and 3
2. acreage of proposed area for the next 1 to 5 years
3. acreage for the entire life of the LCID landfill

Clarify if any waste from grinding will be temporarily stockpiled at the site before final disposal. If so provide:

1. volume (in cubic yards) that will be processed, stored, and for how long (in months)
2. acreage of the storage area for ground material

Note: Please sign and seal the document on which the information is provided.

Landfill gas monitoring is also specified for this facility, per inspection by the Solid Waste Section (SWS) on April 6, 2010 (Doc ID 10665). Monitoring for landfill gas is described in the Operations Plan submitted with the application (Doc ID 10850). Specifications for monitoring landfill gas is specified in Regulation 15A NCAC 13B .0566 (13). To date the Landfill Gas Monitoring Plan requested in the aforementioned inspection has not been submitted.

Please note that landfill monitoring gas plans are now separately reviewed by the SWS hydrogeologists and some standards for landfill gas monitoring have changed.
