AN ORDINANCE APPROVING THE TRANSFER OF A FRANCHISE FROM WCA OF HIGH POINT, INC. TO WI HIGH POINT LANDFILL, LLC FOR CONSTRUCTION AND DEMOLITION LANDFILL AND RECLAMATION OPERATION AT 5830 RIVERDALE ROAD, HIGH POINT, NORTH CAROLINA

WHEREAS, in May 2009, WCA of High Point, Inc. received a franchise by the High Point City Council for the construction and operation of a construction and demolition landfill and reclamation operation located at 5830 Riverdale Road, High Point, NC (“the franchise”); and

WHEREAS, the High Point City Council voted unanimously to approve the transfer of the franchise to WI High Point Landfill, LLC at two readings following public hearings on April 2 and April 16, 2012, upon findings that WI High Point Landfill, LLC had acquired all the assets of WCA of High Point, Inc., that no significant change in the operation of the business would occur, and that WI High Point Landfill, LLC would be an experienced and competent owner and operator of the business under the franchise;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HIGH POINT, NORTH CAROLINA:

That the previous actions of the City Council on April 2 and April 16, 2012 are ratified and confirmed, and that the franchise is transferred from WCA of High Point, Inc. to WI High Point Landfill, LLC.

This ordinance is effective upon adoption.


