I am writing in reference to our Permit to Construct Phase 2 of our Municipal Solid Waste Landfill (MSWLF), Permit No. 54-09. As you are aware, Lenoir County is presently transferring our municipal solid waste to a regional landfill. We still have some space in Phase 1 of our MSWLF; but we are not disposing any waste in it at this time. However, due to economic conditions, the County is delaying the construction of Phase 2 until it is economically more favorable for us to construct Phase 2.

The County understands that we must renew the Permit to Operate (PTO) for Phase 1 on or before February 18, 2015 and this request has to be submitted six months (August 17, 2014) prior to the expiration date. We also understand that we will be charged a permit modification fee for it. Also, we are aware that Phase 1 has to be temporarily covered with one foot of soil and be stabilized with a vegetative cover.
