The item(s) listed above were observed by Section staff and require action on behalf of the facility in order to come into or maintain compliance with the Statutes, Rules, and/or other regulatory requirements applicable to this facility. Be advised that pursuant to N.C.G.S. 130A-22, an administrative penalty of up to \$15,000 per day may be assessed for each violation of the Solid Waste Laws, Regulations, Conditions of a Permit, or Order under Article 9 of Chapter 130A of the N.C. General Statutes. Further, the facility and/or all responsible parties may be subject to enforcement actions including penalties, injunction from operation of a solid waste management facility or a solid waste collection service and any such further relief as may be necessary to achieve compliance with the North Carolina Solid Waste Management Act and Rules.

ADDITIONAL COMMENTS

1. This facility has not accepted waste for several years. It was opened temporarily while the Black Creek Rd facility 98-08T was having a new floor installed. It has been kept in reserve for emergency situations, some recyclables have been accepted at this facility.
2. The Ops Plan lists the operating hours are 6am to 8pm, closed on Sundays.
3. This facility is permitted to receive municipal solid waste generated within Edgecombe, Green, Franklin, Johnston, Lenoir, Nash, Pitt, Wake, Wayne and Wilson Counties. Waste must be transported for disposal to the Sampson County Landfill located in Roseboro, NC, Permit number 82-01. Secondary disposal facilities will be Bertie County Solid Waste Landfill in Aulander, NC, Permit number 08-03, and/or Brunswick Waste Management Facility owned by Allied Waste located in Lawrenceville, VA, Permit number 583.
4. CERTIFICATIONS: Ricky Knight- Certified Transfer Station Operations Specialist, expires November 13, 2012. Pam Price- Certified Transfer Station Operations Specialist, expires October 18, 2015. **More certified operators are needed. During a conversation on 11/27/12 Lee indicated that three other staff members were going to be certified and that Knight was already signed up for a re-certification class.**
5. **98-08T has been reopened and operations have ceased at this landfill. The facility has been cleaned as required.**
