Further, the facility and/or all responsible parties may be subject to enforcement actions including penalties, injunction from operation of a solid waste management facility or a solid waste collection service and any such further relief as may be necessary to achieve compliance with the North Carolina Solid Waste Management Act and Rules.

ADDITIONAL COMMENTS

1. The property is owned by James I Reason (a 7.29 acre tract, parcel ID# 016807 and is recorded in Book 1286 Page 463 of the Nash Co. Register of Deeds. The notification is recorded in Book 1441 Page 877 of the Nash Co. Register of Deeds.
2. The facility is currently not being used and is grown up with brush and small trees.
3. Junk cars and some scrap metal are located in the area but it is not known if any are located over buried waste. **Any junk cars, equipment or scrap metal that is being parked or stored over waste needs to be moved.**
4. The boundary of the waste disposal area is not obvious. **The footprint of the buried waste needs to be located and marked.**
5. Access is controlled by a berm.
6. Mr. Reason has expressed an interest in keeping the facility on the active list if there is an upturn in business.
