Dear Mr. Carroll:

The Division of Waste Management (DWM), Solid Waste Section (SWS) approves the permit amendment application for a ten (10)-year permit to operate for the above-referenced transfer facility. The permit amendment application is titled:

- *Operations Plan. Waste Management – Chatham County Transfer Station, Permit #19-03T. Revised March 2014. (DIN 20698).*

The SWS hereby issues Waste Management of Carolinas, Inc. the Permit to Operate (DIN 20959) to continue operation of Waste Management – Chatham County Transfer Station in accordance with the approved Operations Plan (DIN 20698). This Permit to Operate shall expire **August 17, 2024**. Pursuant to the North Carolina General Statutes (NCGS) 130A-294(a2), no later than **February 18, 2019**, Waste Management of Carolinas, Inc. must submit to the SWS a request for a limited permit review including review of the operations plan, closure plan, environmental monitoring plans, and any other applicable plans for the facility.

Enclosed please find a hard copy of Permit to Operate and the approved Operations Plan for the above-referenced transfer station. The electronic format of the approved documents can be directly downloaded from the DWM's web site at <https://edm.nc.gov/DENR-Portal/>. Type in the Doc ID Number (only numeric number) in the boxed area next to the “**Description**” in the “**Property Criteria**” area. Then click “**Search**” box. The document in “pdf” format will appear on the lower section of the screen called “**Content**” area.
