Dear Ms. Drummond:

Please find attached a Landfill Gas Monitoring Log and an EMRF for the quarterly monitoring event that occurred on August 22, 2013 at the Closed Town of Kernersville Landfill (Permit number 34-04). Methane monitoring for this event was conducted as proposed by JOYCE on behalf of the Town of Kernersville in accordance with approved *Landfill Gas Monitoring Plan*—dated July 17, 2012. Methane was detected in gas monitoring probes GW-1, GW-2R, GW-3, and GW-8 above the LEL during this monitoring event.

During this event three probes belonging to the adjacent Waste Management Piedmont landfill GP-9, GP-10, and GP-11 were also monitored for methane gas. In the Piedmont landfill boundary probe GP-10 methane gas was detected above the LEL. As has been noted in the past, it is likely that the impacts observed at GP-10 are likely the result of migration from the Kernersville landfill. The results in GP-10 are consistent with those seen in the northern boundary probes of Kernersville and inconsistent with other probes surrounding the Piedmont Landfill. The migration from the Kernersville Landfill are presently being addressed through a Landfill Gas Corrective Action Plan currently being prepared. A map has been included in this report to illustrate the proximity of the two landfills and the gas probes between them.


