





CONDITIONS OF PERMIT

1. This facility is permitted to receive solid waste as defined in 15A NCAC 13B .0101 (36), except that hazardous and liquid wastes are prohibited from acceptance at this facility.
2. This facility may only receive solid waste that is generated within Lee, Chatham, Wake, Harnett, and Moore Counties as described in the permit application and is to be disposed of at the Piedmont Landfill in Kernersville, North Carolina.
3. This permit shall be reviewed every five (5) years. Modifications shall be in accordance with the Rules in effect at the time of review.
4. This permit is for construction/operation of the transfer facility in accordance with the approved plans. Any revisions or modifications to these plans shall be approved by the North Carolina Solid Waste Section.
5. The following requirements shall be met prior to receiving solid waste at the site:
 - a. Site preparation shall be in accordance with the construction plan.
 - b. Site inspection shall be made by a representative of the NC Solid Waste Section.
 - c. The permit number and the words "No hazardous or liquid wastes accepted" shall be posted on an entrance sign.
6. Operation of the facility shall occur in accordance with 15A NCAC 13B .0402, "Operational Requirements for Transfer Facilities" and the OPERATIONS PLAN, prepared by Marlowe, Dreitzler & Associates, approved by the Solid Waste Section for this facility, along with these additional requirements:
 - a. This facility shall be operated in a manner which is consistent with the State solid waste management plan and with the solid waste management plans that have been adopted by those units of local government served by the facility and approved by the Section.

- b. On or before 1 August 1993 and each year thereafter, the owner or operator shall report to the NC Solid Waste Section, for the previous year beginning 1 July and ending 30 June, the amount by weight of the solid waste that was received at the facility and disposed of in a landfill, incinerated, or converted to fuel. To the maximum extent practicable, such reports shall indicate by weight the COUNTY of origin of all solid waste. The owner or operator shall transmit a copy of the report to the county in which the facility is located and to each county from which waste originated.
