Dear Mr. Jones:

The Division of Waste Management, Solid Waste Section records indicate the solid waste management Permit to Operate for the Recycled Material, Inc. facility, Permit No. 9608-MWP, expired on June 2, 2007.

A comprehensive audit of the facility conducted on June 21 and 27 of 2011, noted violations of the 15A North Carolina Administrative Code 13B, the Solid Waste Management Rules, including violation of Rule .0202(a). This rule states that "No person shall treat, store, or dispose of solid waste or arrange for the treatment, processing, storage or disposal of solid waste except at a solid waste management facility permitted by the Division for such activity, except as provide in G.S. 130A-294(b)". The audit report (Document Id No. 14366) stated that an application to renew the permit needed to be submitted within 30 days. A permit renewal application was not received. It is our understanding that the facility no longer receives waste. Therefore, the Solid Waste Section hereby rescinds Permit No. 9608-MWP.
